INCENTIVE

Monthly Net Amount can be arrived after deduction of total expenses from total receipts. Gross Incentive amount calculated after multiplying given percentage to Net amount. Calculated Gross Incentive will be paid in the following manner.

- 1) Calculate Incentive payable to each eligible agent. If available Gross Incentive amount is less than the total of amount mentioned in rule 9 of eligible agent, then equal amount will be paid to each eligible agent.
- 2) If balance remains after deduction of amount calculated as per number one above, calculate Special Incentive payable to each eligible agent. If available amount is less than the total of amount mentioned in rule 9 of eligible agent, then equal amount will be paid to each eligible agent.
- 3) If balance remains after deduction of amount calculated as per number two above, calculate Bonus Incentive payable to each eligible agent. If available amount is less than the total of amount mentioned in rule 5 of eligible agent, then equal amount will be paid to each eligible agent.

- 6) Minimum 75 Shopkeeper account must be active while calculation of incentive every month.
- 7) Minimum 50% of Service provider account must be active while calculation of incentive every month.
- 8) Incentive false due from the month of first fulfilling the above Seven conditions.
- 9) Incentive per month cannot exceed Rs.50,000/-
- 10) Incentive payable till the age of 70.
- 11) Incentive will be discontinued on termination of account, death of account holder.

RULES FOR SPECIAL INCENTIVE CALCULATION

Calculation of Special Incentive

- 1) Agent must activate new 80 shopkeeper. Out of active shopkeeper 50% shopkeeper must avail delivery boy service.
- 2) Agent must activate new 800 customers.
- 3) You must activate 15 new agent registrations.
- 4) Each agent, activated by you, must activate new 30 shopkeeper application.

- 5) You must activate new 40 service provider application.
- 6) Minimum 75 Shopkeeper account must be active while calculation of incentive every month.
- 7) Minimum 50% of Service provider account must be active while calculation of incentive every month.
- 8) Incentive false due from the month of first fulfilling the above Seven conditions.
- 9) Incentive per month cannot exceed Rs.5,000/-
- 10) Incentive payable till the age of 70.
- 11) Incentive will be discontinued on termination of account, death of account holder.
- 12) Agent's eligible for incentive will not get special incentive.

RULES FOR BONUS INCENTIVE CALCULATION

Calculation of Bonus Incentive

- 1) You must activate 240 new agent application in three stages (i.e.1,15,225) within 45 day's from joining you as Agent.
- 2) Minimum 90% Shopkeeper accounts must be active while calculation of bonus incentive.
- 3) Minimum 70% of Service provider accounts must be active while calculation of bonus incentive.
- 4) Bonus Incentive false due from the month of first fulfilling the above Three conditions.
- 5) Bonus Incentive per month cannot exceed Rs.2,50,000/-
- 6) Bonus Incentive payable till the age of 70.
- 7) Bonus Incentive will be discontinued on termination of account, death of account holder.

MobiShop reserves the right to change its Fee Policy from time to time.
